# **GLOBAL VISITOR INSURANCE COVERAGE**

## **EXCLUSIONS**

It is important to know that several exclusions apply to this insurance. The most important exclusions are:

- We do not reimburse costs that are the result of ailments, complaints or physical impairments that already exist on the commencement date of the insurance. This applies even if you did not know that you had that ailment, complaint or physical impairment.
- We further do not reimburse costs that are the result of diabetes mellitus, gall stones, kidney stones or pregnancy/delivery. A complete summary of the exclusions can be found in the <u>policy terms and conditions</u>.

### COVERAGE

### **Medical expenses**

- We will only reimburse the costs listed below if they are medically necessary.
- The maximum that we reimburse is the amount approved by the official institutions in the country where the medical treatment is given. In the Netherlands, that institution is the Dutch Health Care Authority, known as the NZa.
- We will reimburse a maximum of twice the tariff that applies within the Netherlands for costs that are incurred outside the Netherlands.
- Any costs will be paid up to a maximum total payment of € 500,000 per person insured per period insured.
